1. ALL practices and games will be held at Parchment Valley Conference Center or the Millwood Armory.
There will be one practice per team before games begin. We will **NOT** be ordering shirts this year - we will be using pinnies to separate teams. This is to save money. All money brought in goes toward referees, insurance, and building fees.
2. Games will be in January through February. If a game is canceled it will not be rescheduled. We have a tight calendar and won't have time for this.
3. RYSC's code of conduct must be followed. The buildings we are using is a church facility and a government facility. Smoking, alcohol, drugs, and foul language is not permitted in or around the facilities. No pets allowed!
4. Parents are responsible for your children, they are not permitted to play in the back rooms or the bathrooms. Parents are responsible for cleaning up your own child's mess. There are plenty of trashcans, please use them!
5. Please do not use a flash if you are taking pictures. This can be dangerous for some people, causing seizures.
6. Parchment Valley Parking - NO parking in the loop or at the top by the building (this doesn't include handicap parking). This is a fire hazard. The parking lot is below the building and has plenty of room for parking.
7. Parchment Valley - Entrance is at the side door to the gym. NOT in the front door.
8. No drinks are permitted in the gyms unless they are in a bottle with a screw on lid. There is a water fountain if anyone needs a drink.

RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AND PARENTAL CONSENT AGREEMENT ("AGREEMENT")

IN CONSIDERATION of being permitted to participate in any way in RYSC Indoor Soccer(Ripley Youth Soccer Club) activities ("Activities") I, for myself for personal representatives, assigns, heirs, and next of kin:

ACKNOWLEDGE, agree, and represent that I understand the nature of RYSC Activities and that I am qualified, in good health, and in proper physical condition to participate in such Activities. I further agree and warrant that if at any time I believe conditions to be unsafe, I will immediately discontinue further participation in the Activity.

FULLY UNDERSTAND THAT: (a) Ripley Youth Soccer Club Indoor Soccer ACTIVITIES INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS, AND DEATH ("RISKS"); (b) these Risks and dangers may be caused by my own actions or inaction's, the actions or inaction's of others participating in the Activity, the condition in which the Activity takes place, or THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW; (c) there may be OTHER RISK AND SOCIAL AND ECONOMIC LOSSES either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I incur as a result of my participation or that of the minor in the Activity.

HEREBY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE Ripley Youth Soccer Club, their respective administrators, directors, agents, officers, members, volunteers, and referees, other participants, any sponsors, advertisers, and, if applicable, owner and lessors of premises on which the Activity takes place (Parchment Valley Conference Center and/or Millwood Armory), (each considered one of the "RELEASEES" herein) FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGES ON MY ACCOUNT CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE "RELEASEES" OR OTHERWISE, INCLUDING NEGLIGENT RESCUE OPERATIONS AND I FURTHER AGREE that if, despite this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT I, or anyone on my behalf, makes a claim against any of the Releasees, I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASEES from any litigation expenses, attorney fees, loss, liability, damage, or cost which may incur as the result of such claim.

I HAVE READ THIS AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND HAVE SIGNED IT FREELY AND WITHOUT INDUCEMENT OR ASSURANCE OF ANY NATURE AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW AND AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID THE BALANCE, NOTWITHSTANDING, SHALL CONTINUE IN FULL FORCE AND EFFECT.
