*****PLEASE NOTE*****

1. All players will receive t-shirts with matching socks as their uniform. Shorts are not provided.
2. Players need to be at practices and games. Players may not be guaranteed 50% playing time if they miss practices, games, or are late to a game. Exceptions may be granted for illness, injury, and disciplinary reasons.
3. U8 Players and up MUST arrive 15 minutes prior to the game for equipment check by the referees. Shin guards are required to play/practice. Shoes cannot have a toe cleat.
4. A birth certificate must be on file for child to participate. If one is not, the child's form will be held, till one is made available.
5. When your child pays/plays in the fall, this includes the spring season as well. Your child will have the same team/coach/shirt in the spring that they have in the fall.

RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK ("AGREEMENT")

IN CONSIDERATION of being permitted to participate in any way in RYSC Soccer (Ripley Youth Soccer Club) activities ("Activities") I, for myself for personal representatives, assigns, heirs, and next of kin: ACKNOWLEDGE, agree, and represent that I understand the nature of RYSC Activities and that my child is qualified, in good health, and in proper physical condition to participate in such Activities. I further agree and warrant that if at any time I believe conditions to be unsafe, I will immediately discontinue further participation in the Activity.

FULLY UNDERSTAND THAT: (a) Ripley Youth Soccer Club Soccer ACTIVITIES INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS, AND DEATH ("RISKS"); (b) these Risks and dangers may be caused by child's own actions or inaction's, the actions or inaction's of others participating in the Activity, the condition in which the Activity takes place, or THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW; (c) there may be OTHER RISK AND SOCIAL AND ECONOMIC LOSSES either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES my child incur as a result of his/her participation in the Activity.

HEREBY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE Ripley Youth Soccer Club, their respective administrators, directors, agents, officers, members, volunteers, and referees, other participants, any sponsors, advertisers, and, if applicable, owner and lessors of premises on which the Activity takes place, (each considered one of the "RELEASEES" herein) FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGES ON MY ACCOUNT CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE "RELEASEES" OR OTHERWISE, INCLUDING NEGLIGENT RESCUE OPERATIONS AND I FURTHER AGREE that if, despite this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT I, or anyone on my behalf, makes a claim against any of the Releasees, I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASEES from any litigation expenses, attorney fees, loss, liability, damage, or cost which may incur as the result of such claim.
